The last one is Available 24 hours / day - 7 days / week, meaning that mastery of the material depends on the enthusiasm and absorption of students, can be monitored, can be tested by e-test. The drawbacks of E-Learning according to L. Gavrilova (2006: 354) is learning with the E-learning model requires more additional equipment (such as computers, monitors, keyboards, etc.). Lack of E-learning described by Nursalam and Efendy (2008: 140) is that E-learning makes Lack of interaction between teacher and students or even between students themselves, a tendency to ignore academic or social aspects and vice versa to grow business / commercial aspects. Not all internet facilities are available (maybe this is related to the problem of the availability of electricity, telephone, or computer). Finally, not all students can master the internet.

University Muhammadiyah of Purwokerto has long used E-Learning as a form learning recognized by the leader's university. Lecturer in English Education Department at University Muhammadiyah Purwokerto has used E-learning, both in upload form documents (Exam Questions, Learning

Materials) as well as online learning activities such as discussions and assignments. Implementation of learning through E-learning needs to be studied more deeply with see students' responses to the learning process based on E-learning, so can be known form of learning based E-learning desired by students. This study aims to find out students' perceptions on the use of E-Learning in the writing class.
