CHAPTER I: INTRODUCTION

In other words, a woman's love includes behaviors motivated by genuine feelings. Just as a king instructs his servants and expects them to act in a certain way, it is the heart that loves and the body and mind follow the dictates of the heart.

Many people think of love as an emotion, something that involves emotion rather than reason, something that comes from the heart rather than the intellect. Therefore, it is a prevalent misconception that falling in love is a conscious decision; instead, falling in love is a largely passive experience (Saddler, 2018). Love is commonly believed to be uncontrollable, unavoidable, mysterious, or intangible energy. The idea that love defies

explanation, accountability, or prediction, that it is beyond the control of human will, or that it is immune from rational inquiry, is not exclusive to folk beliefs or romantic comedies. Numerous philosophers hold it. Additionally, love is seen to be a very potent emotion having the ability to dominate many parts of thinking and feeling, as well as have a significant impact on deliberation and decision-making.

In relation to this discussion, this research will discuss the view of love from the woman's side as portrayed in some song lyrics. Song lyricists typically draw inspiration from their own experiences and events when writing lyrics (Lisara, 2014). Songs have messages in them, both overtly and covertly, just like any other literary text. A literary text's meaning must almost always be clear to the reader. The relationship between song lyrics and their message then emerges because a songwriter always infuses their music with their intended meaning, whether they are aware of it or not.

Regarding its relationship with women's view of love, this study will take some song lyrics which illustrate the menaing of love from the woman's side through the various kinds of love theory. The song lyrics that will be used in this study come from the well-known English singer, Adele. The reason is because most of Adele's song lyrics tell about love relationships and heartbreak.

The topic of discussing the view of love from the female side is quite interesting to discuss, because it often appears and is expressed through song lyrics, whether from women or men. Moreover, many songs today tell about something related to romance, such as confessing feelings of love that cannot be conveyed, breaking up, love for their partner, feeling traumatized by the failure of love, etc. The things that have been mentioned are problems that are often faced by most young people and relate to life. The results of this research will reveal the reasons why Adele often writes songs that tell about the twists and turns of her romance, as well as what are the different views of love from each song lyric she wrote from her teenage years to her 30s.

Adele's song lyrics to be studied include: "Chasing Pavements" (2008), which tells of her indecision in deciding the fate of her relationship with the lover she hopes to commit to seriously. The second song entitled "Someone Like You" (2011), tells the story of a woman whose lover or ex has found someone he loves, and even though she is no longer with him, this woman always wishes the best for the man, even though she still loves the man. And The third song entitled "Send My Love (To Your Lover)" (2015), tells the story of her being given hope by her lover, but suddenly the lover turned to another heart, but Adele still hopes for the best for him despite being given false hopes.

A song holds a significant place as an accessible art form within social life, offering enjoyment without demanding extensive comprehension. Songs serve as potent mediums to articulate emotions and reflect upon lived experiences. Through their intricate wordplay and poignant connections to

real-life scenarios, certain songs earn the status of masterpieces. Among the diverse themes explored in songs, romance remains a prominent subject. This research aims to explore the female perspective on love encapsulated in various song lyrics. It specifically delves into three song samples from the celebrated British singer, Adele, seeking to dissect and analyze her portrayal of love. The research aims to understand Adele's meaaning of love through a descriptive qualitative method, utilizing theories such as kinds of love and Genetic Structuralism by Lucien Goldman. By scrutinizing these song lyrics, the study seeks to unveil Adele's character and her responses in navigating love stories conveyed in her song.

- 1. How does Adele show her view of love as represented in her lyrics?
- 2. Which category of love type matches her behavior?

C. Purpose of the Research

- 2. Determine the category of love type that matches her behavior.
